Dear Chairman Simpson and Ranking Member Moran:

As a uniquely broad coalition of environmental, science-based, public health, industry, labor and state and local government groups, we would like to express our thanks for your prior investments in the Diesel Emission Reduction Act (DERA) program and state and local air quality grant programs. However, there are 20 million existing diesel engines in use today and immense opportunities remain to reduce diesel emissions through the DERA program. We respectfully request your continued support of this important program and ask that your Committee provide \$50 million for the DERA program in Fiscal Year (FY) 2012 (equal to FY 2008 levels). We also urge you to support the President's budget request of \$305.5 million for state and local air quality grants in FY 2012.

Diesel-powered vehicles and equipment play an important role in the nation's economy and are getting cleaner every day. DERA was designed to reduce emissions from the 20 million existing diesel engines in use today by as much as 90 percent. The continued need for DERA has been proven.

Since enactment in 2005, DERA has been successful from an economic, environmental and public health perspective. The DERA program has been responsible for the creation and retention of local US jobs that involve manufacturing, installation and servicing of emissions related technologies. In a FY 2008 Report to Congress, the Environmental Protection Agency (EPA) estimates that for every dollar spent on the DERA program, an average of more than \$20 in health benefits are generated. Every state in the nation now has a diesel retrofit program and benefits from DERA funding.

Throughout DERA's history, it has enjoyed strong bipartisan support; most recently demonstrated this past December when Congress took the extraordinary step of reauthorizing this important program during the lame duck session. We need your support to ensure the program's continued success. Without additional funding, the

DERA program, and its environmental, public health, and economic and jobs benefits, will be in jeopardy.

We also request that you support the President's budget request of \$305.5 million for state and local air quality grants in FY 2012. We support this level of funding because state and local air quality agencies are under-funded and face increasing responsibilities – such as attaining and maintaining National Ambient Air Quality Standards, implementing clean air rules, and addressing toxic air pollutants.

States and localities and environmental, health, user and industry groups all support funding for diesel retrofits and clean air agencies because it is sound environmental, health and budgetary policy. It is our hope that Congress will continue to provide leadership on this issue and we urge you to allocate \$50 million for DERA and request that state and local air quality grants be funded at \$305.5 million because these grants are vital to achieve and sustain clean air and protect public health across the nation.
