



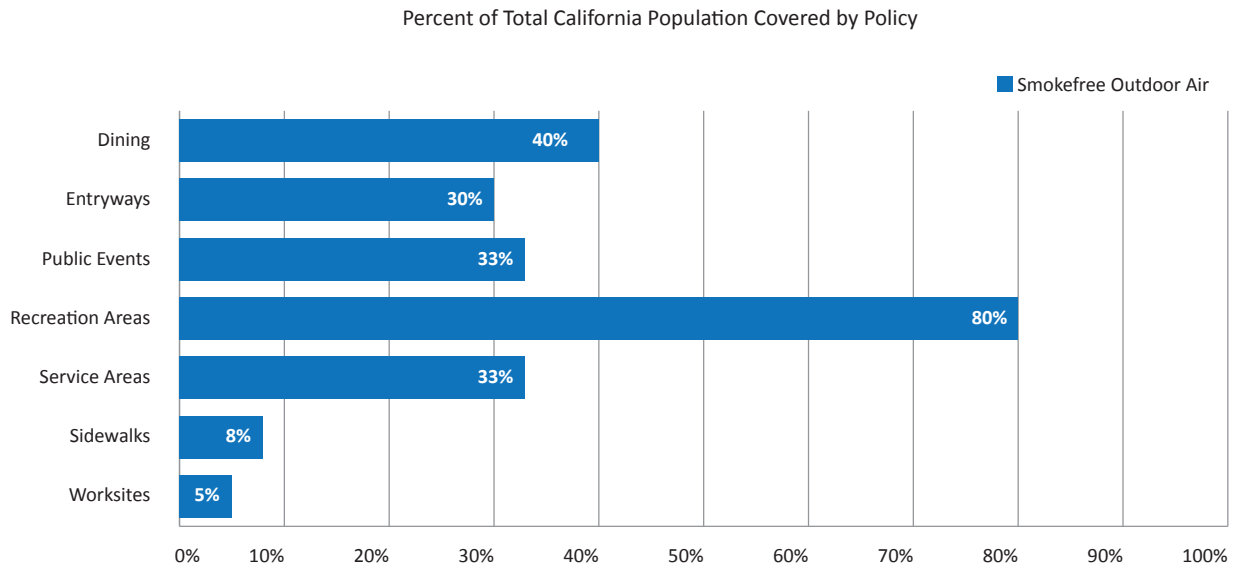
## CALIFORNIA TOBACCO CONTROL BY THE NUMBERS

By grading every city and county in California, the *State of Tobacco Control 2015 – California Local Grades* report paints a comprehensive picture of how well local elected officials across the state protect the residents of California. Below is a breakdown of all the tobacco control policies in California, followed by the Overall Tobacco Control grade for every municipality, and a list of the cities and counties with the top grades in each category.

### BREAKDOWN OF ALL TOBACCO CONTROL POLICIES IN CALIFORNIA

#### SMOKEFREE OUTDOOR AIR

- **129** cities/counties restrict smoking at outdoor dining areas, covering **40%** of the total population in California
- **117** cities/counties restrict smoking within entryways of buildings, covering **30%** of the total population in California
- **118** cities/counties restrict smoking at public events, covering **33%** of the total population in California
- **348** cities/counties restrict smoking in recreation areas, covering **80%** of the total population in California
- **121** cities/counties restrict smoking at service areas, covering **33%** of the total population in California
- **48** cities/counties restrict smoking on sidewalks in commercial areas, covering **8%** of the total population in California
- **45** cities/counties restrict smoking at outdoor worksites, covering **5%** of the total population in California

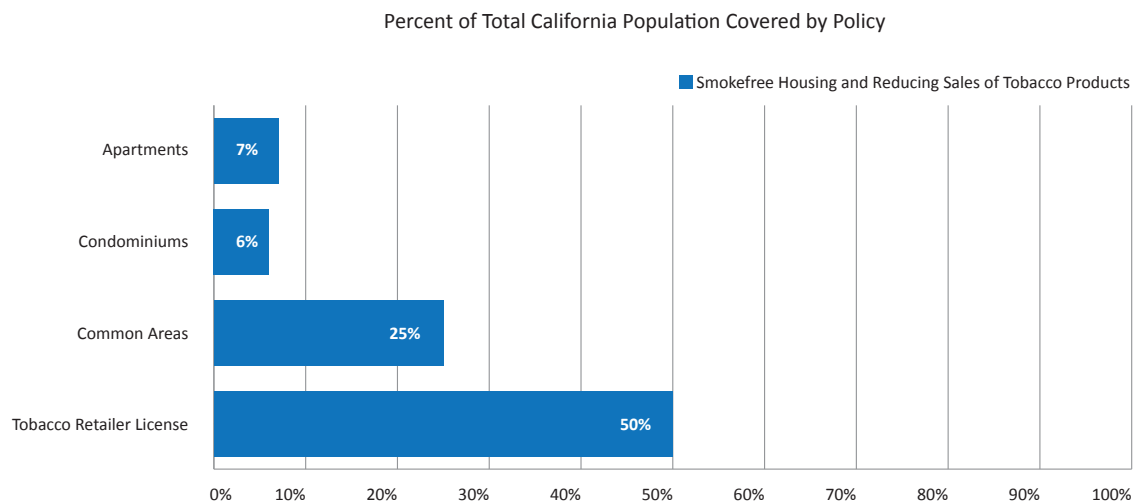


### SMOKEFREE HOUSING

- **39** cities/counties require the creation of nonsmoking units in multi-unit apartment buildings, covering **7%** of the total population in California
- **35** cities/counties require the creation of nonsmoking units in multi-unit condominium buildings, covering **6%** of the total population in California
- **117** cities/counties restrict smoking in indoor and/or outdoor common areas of multi-unit housing, covering **25%** of the population in California
- **40** cities/counties require the creation of nonsmoking units in Housing Authority housing

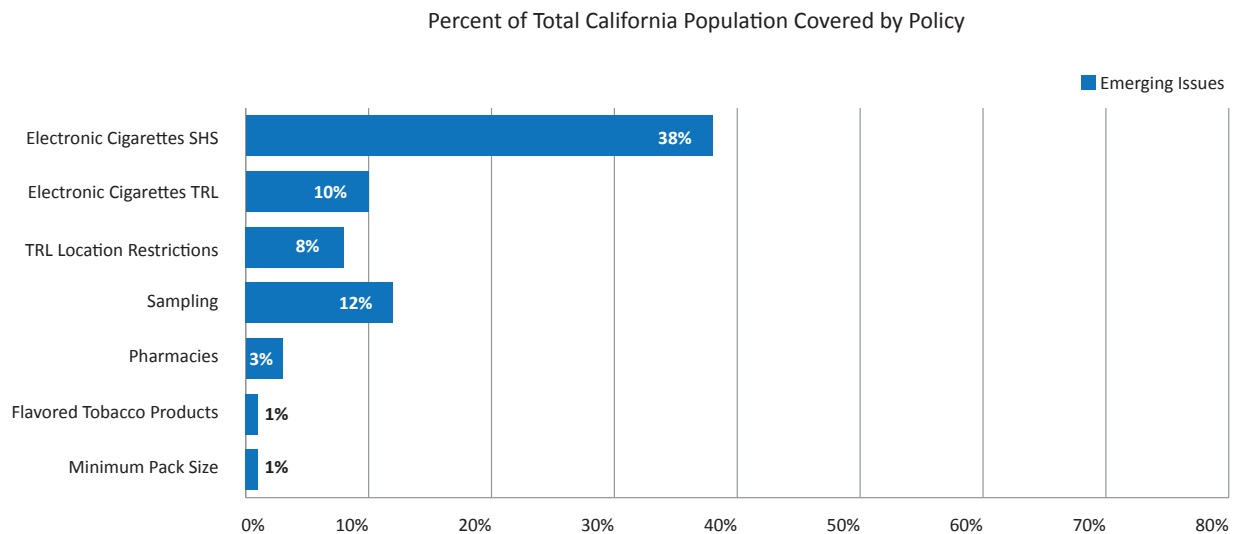
### REDUCING SALES OF TOBACCO PRODUCTS

- **148** cities/counties require tobacco retailers to obtain a local license to sell tobacco products, covering **50%** of the total population in California



**EMERGING ISSUES**

- **122** cities/counties have a strong definition of smoke, smoking, or tobacco product that includes electronic cigarettes or other new and emerging tobacco products in a jurisdiction’s secondhand smoke laws, covering **38%** of the total population in California
- **91** cities/counties have a strong definition of smoke, smoking or tobacco product that would include electronic cigarettes or other new and emerging tobacco products in a jurisdiction’s tobacco retailer licensing ordinance, covering **10%** of the total population in California
- **38** cities/counties restrict the sale of tobacco products within a certain distance of schools/parks, covering **8%** of the total population in California
- **46** cities/counties restrict the sampling of tobacco products, covering **12%** of the total population in California
- **6** cities/counties restrict the sale of tobacco products at pharmacies, covering **3%** of the total population in California
- **2** cities/counties prohibit the sale of flavored tobacco products, including cigar, little cigars, pipe tobacco and electronic cigarettes is prohibited, covering approximately **1%** of the total population in California
- **2** cities/counties prohibit the sale of cigars in individual or small packages, covering approximately **1%** of the total population in California

### D grade for Overall Tobacco Control

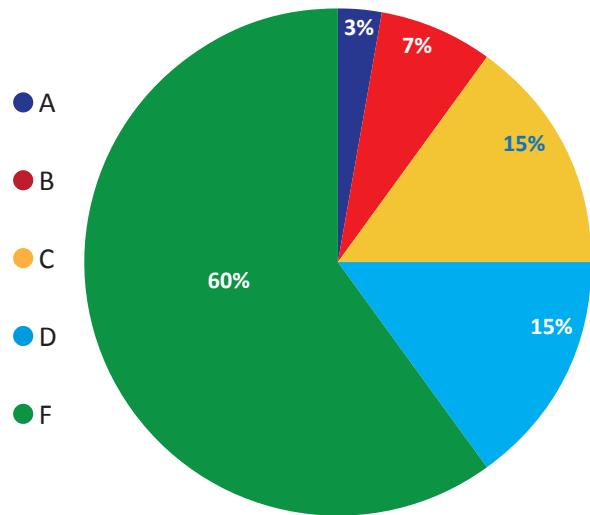
- 83 cities/counties received a D grade

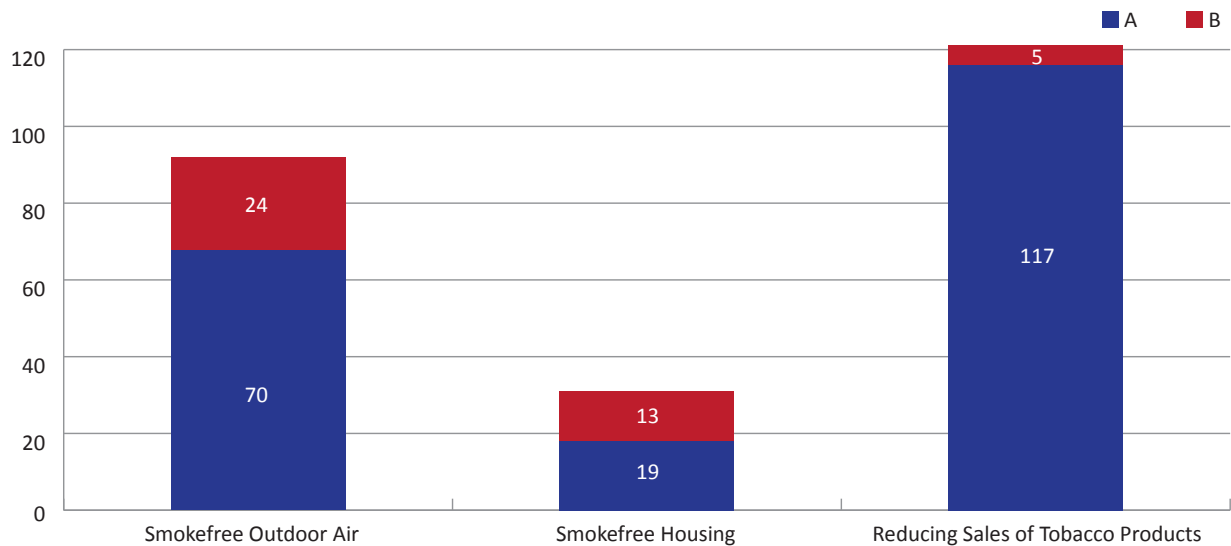
