## ILLINOIS SMOKEFREE HOUSING DIRECTORY

### Recognition Program

The Illinois Smokefree Housing Directory & Recognition Program is a comprehensive listing of all multi-unit properties in the state of Illinois that have adopted a smokefree policy.

The directory and recognition program was established in 2012 to acknowledge properties that have adopted smokefree policies, encourage additional property owners/managers to adopt a smokefree policy and to assist tenants in locating a smokefree property.

Properties listed in the directory receive a certificate of recognition from the American Lung Association in Illinois—Greater Chicago. Their name is also listed in the Smokefree Housing Directory online.

The recognition level is based on the type of smokefree policy the property has adopted. There are 4 levels of recognition available, and levels will be updated as more units or portions of the grounds become smokefree.



#### Gold

100% of resident lease agreements include smokefree policy, making all units and common areas smokefree AND 100% of property grounds are smokefree.



#### Silver

100% of resident lease agreements include smokefree policy, making all units and common areas smokefree AND smoking prohibited on property grounds within 15 feet of buildings.

OR

More than 50% of resident lease agreements include smokefree policy AND 100% of property grounds are smokefree.



#### Bronze

More than 50% of resident lease agreements include smokefree policy AND smoking prohibited on property grounds within 15 feet of buildings.

OR

Less than 50% of resident lease agreements include smokefree policy AND 100% of property grounds are smokefree.



#### Honorable Mention

Less than 50% of resident lease agreements include smokefree policy AND smoking prohibited on property grounds within 15 feet of buildings.
